### Section 4 - FIRST AID MEASURES

#### Description of first aid measures

Eye Contact	: If this product comes in contact with the eyes: Wash out immediately with fresh running water. #### Methods and material for containment and cleaning up

Minor Spills	: Remove all ignition sources. Clean up all spills immediately. Avoid breathing vapours and contact with skin and eyes. Place in a suitable, labelled container for waste disposal.
Major Spills	: Moderate hazard. Clear area of personnel and move upwind. Alert Fire Brigade and tell them location and nature of hazard. Wear breathing apparatus plus protective gloves. Prevent, by any means available, spillage from entering drains or water course. No smoking, naked lights or ignition sources. Increase ventilation. Stop leak if safe to do so. Contain spill with sand, earth or vermiculite. Collect recoverable product into labelled containers for recycling. Absorb remaining product with sand, earth or vermiculite. Collect solid residues and seal in labelled drums for disposal. Wash area and prevent runoff into drains. If contamination of drains or waterways occurs, advise emergency services.
